



## NARI CERTIFIED KITCHEN AND BATH REMODELER APPLICATION (CKBR)

**This application is the first step in earning the Certified Kitchen and Bath Remodeler (CKBR) designation.**

Please read and complete each section fully and accurately in clear, legible handwriting or type. You may submit your application anytime during the year; however, all qualifying remodeling experience and continuing education must be completed at the time the application is submitted. **A complete application must be received by NARI Milwaukee and NARI Headquarters 10 days prior to the start of your study group to receive class materials on time.**

There is not a membership requirement to apply for the CKBR exam. Both NARI members and non-members will be evaluated equally on the application and subsequent examination. The CKBR program does not discriminate on any basis including race, sex, age, religion, national origin, sexual orientation or disability. ***Definition of Certified Kitchen and Bath Remodeler:*** Remodeling professionals who specialize in kitchen and bath remodeling projects. CKBRs possess honed expertise in materials, layout and installation particular to kitchen and bath renovations, making them an indispensable resource to clients with these specific project needs.

***How the certification process works:*** Certification candidates have two examination prep options available – in-person study group organized at the NARI Milwaukee Chapter or the online CKBR prep course offered by NARI National. The in-person study group meets weekly at the NARI Milwaukee office in Wauwatosa. The fee is \$300 for members and \$400 non-members.

The online CKBR prep course is offered regularly by NARI National. Find more information about the online course here: <https://www.nari.org/Certification-Accreditation/Individual-Certification/Preparatory-Courses>. You can register for the online prep course and join the in-person study group for final test prep sessions (1 or 2 sessions) for \$150. An exam proctor fee of \$65 also applies if a student participates in the online prep course and takes the exam at NARI Milwaukee. In person testing is a required component of certification.

***Requirements for Certification:*** Candidates must complete and submit this application for consideration by the NARI Certification Board. In addition to completing and submitting an application, you must have at least **5 consecutive years of full time experience in the remodeling industry** leading up to application, as well as **have completed at least 4 kitchen and/or bath**

**remodels** within the past year. Candidates must have attained a minimum of **16 hours of continuing education** within the 5 years prior to application *or* participate in the NARI Milwaukee study group *or* enroll in the online CKBR prep course offered by NARI National.

**Certification Renewal:** Certifications are renewed **annually**. Renewals currently require the attainment of 10 hours of continuing education credits and the submission of the required renewal fee.

Eligible education includes any remodeling-related education, either in person or online, including college courses, which is free of sales promotions. Sales, marketing and business training and educational sessions are also accepted for continuing education. **\* Certification Fees:** The Certification fee is \$500 for members and \$700 for non-members. Included in the certification fee is a \$100 non-refundable processing fee. If the candidate does not meet the eligibility requirements for the CKBR designation, they will only be refunded the outstanding balance of the certification fee, \$400 (members) or \$600 (non-members). Once the application has been approved, all fees are non-refundable.

**\*\* Study Group Course Fees:** If cancellation is made for any reason 7 days or less prior to course start date, fees are non-refundable.

The certification fee includes the cost to take the initial examination once within 24 months of submission of the application if the applicant takes the in-person study group at NARI Milwaukee. If the applicant takes the online course there is a \$65 test proctoring fee. Subsequent examinations are subject to additional re-test fees. (Limit of two re-tests within 2 years of original application date).

If your company was awarded a scholarship by virtue of winning a CotY regional award at the National program you may credit the certification fee by \$100. If your company also won the National CotY award you may credit an additional \$50 for a maximum of \$150 per new certification application. Scholarship money awarded is valid through the dates stated on your CotY award letter.
